What is the overall <a href="#">deductible</a> ?	In-Network: <b>\$1,500</b> Individual / <b>\$3,000</b> Family. Out-of-Network: <b>\$3,000</b> Individual / <b>\$6,000</b> Family.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive care</a> , Behavioral Health services, Covid-19 testing, treatment, vaccines.	This <a href="#">plan</a> covers some items & services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. - Weight Loss Programs (Includes coverage for drugs and programs if medically necessary for morbid obesity and obesity)
