WHO WE ARE

Dr. Dan C. Trigg Memorial Hospital (DCT) is a county-owned Critical Access Hospital that has been managed by nonprofit Presbyterian Healthcare Services since 1978. We operate a hospital with a 24-hour emergency department, inpatient medical care, a swing bed program, primary care and specialty care clinics, and home health and hospice services in Quay County.

OUR SERVICES

At DCT, the following outpatient services are offered: emergency medicine, family medicine, CT, laboratory, mammography, MRI, radiology, rehabilitation services, sleep medicine, ultrasound and infusion services.

CARING FOR OUR COMMUNITY

As a community-based healthcare provider, our focus is on providing safe, compassionate and equitable care that keeps our patients and members healthy.

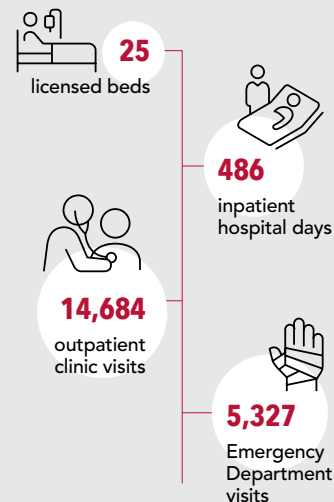
- LaDonna Chacon, certified adult gerontology primary care nurse practitioner, joined our talented team in 2024, providing care for patients ages 13 and older at our clinics in Tucumcari and Logan.
- We expanded hours at our Presbyterian Medical Group clinics in 2024, including expanded walk-in hours for our patients.
- Our Tucumcari Home Health and Hospice Agency provides skilled care to patients who need specialized medical care and are considered homebound, but who do not need the 24-hour monitoring of a hospital or nursing home. We also provide physical, emotional and spiritual support to terminally ill patients and their families.
- DCT Memorial Hospital has the only emergency department between Albuquerque and Amarillo, Texas, staffed 24/7 by an on-site provider.
- Partnering with New Mexico State University, we offered a Kitchen Creations program that focused on nutrition and cooking for adults with diabetes. Participants learned how to plan and prepare meals that manage carbohydrates and promote heart health. The class was offered free to all community members.

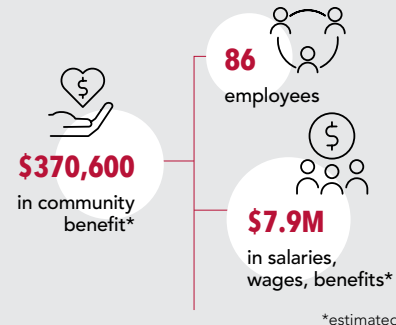
