Presbyterian Medicare Advantage plans include Presbyterian Senior Care (HMO) / (HMO-POS) and Presbyterian Dual Plus (HMO D-SNP). Presbyterian Senior Care (HMO) / (HMO-POS) is a Medicare Advantage plan with a Medicare contract. Enrollment depends on contract renewal. Presbyterian Dual Plus is an HMO Special Needs Plan (SNP) with a Medicare contract and a contract with the State of New Mexico Health Care Authority Medicaid program. Enrollment depends on contract renewal. Based on a Model of Care review, Presbyterian Dual Plus (HMO D-SNP) has been approved by the National Committee for Quality Assurance (NCQA) to operate a Special Needs Plan (SNP) through 2028. You may be eligible to receive money for a special supplemental grocery benefit (SSBCI) if you have been diagnosed with a chronic condition of diabetes, congestive heart failure (CHF), hypertension, or hyperlipidemia. You must have had an annual wellness visit in the last 12 months. Eligibility is determined by your plan, and you may not be eligible even though you have one of these conditions.
